- **OWNERSHIP** I am the legal owner of the above named dog/puppy(s) and I assume all risks, dangers, and responsibility for injuries to the named dog/puppy(s). Owner understands and agrees that Owner is solely responsible for any harm while Owner's dog/puppy(s) is/are attending Boarding & Grooming..
- **PICTURE RELEASE:** I love posting pictures on Facebook and/or my website. Owner agrees to allow Barnes-n-Bubbles K9 Spa to use Owner's pet's name and any images or likeness of Owner's pet taken while he/she is at Barnes-n-Bubbles K9 Spa, in any form, for use at any time, in any media, without compensation, and Owner releases to Barnes-n-Bubbles K9 Spa all rights that Owner may possess or claim to such images.
- **DOG/PUPPY'S HEALTH:** Owner further understands and agrees that Owner's dog/puppy(s) are healthy and while attending Barnes-n-Bubbles K9 Spa are current on all vaccinations:(rabies, distemper and Bordetella) Owner has noted above **any condition** that could potentially jeopardize the health of other dogs, staff or people. Owner further understands that even if Owner(s) dog is vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner's dog can still contract Kennel Cough. Owner agrees that Owner will not hold Barnes-n-Bubbles K9 Spa responsible if Owner's dog/puppy(s) contracts Kennel Cough or other dog-dog transmitted ailments.
- **FLEA/TICK FREE:** All dogs/puppies must be flea/tick free. If a dog/puppy is observed to have fleas or ticks, a flea/tick bath treatment will be applied and charged to the owners bill. This rate can range from \$40 to \$80.00 depending on severity and size of dog/puppy.
- **PLAY TIME:** All Dogs must pass a general behavior assessment in order to attend doggie playtime. No dog may be admitted to group play who shows any signs of any type of **aggression**. Owner further understands and agrees that in admitting Owner's dog/puppy(s) to doggie playtime, Owner is representing to Barnes-n-Bubbles K9 Spa that Owner's dog/puppy(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dogs. Any dog demonstrating aggression or other behavior deemed unacceptable by Barnes-&-Bubbles K9 Spa staff may be required to leave boarding & grooming.
- **RELEASE OF LIABILITY:** Owner understands and agrees that during normal dog play, the Owner's dog may sustain injuries. Dog play is monitored by Barnes-n-Bubbles K9 Spa staff to best avoid injury, but scratches, punctures, torn ligaments, and other

injuries may occur despite the best supervision. Owner further understands and agrees that neither boarding & grooming nor any of its employees, staff, or volunteers will be liable for any illness, injury, death, and/or escape of Owner's dog/puppy(s) provided that reasonable care and precautions are followed, and Owner hereby releases Barnes-n-Bubbles K9 Spa staff or volunteers of any liability of any kind whatsoever arising from or as a result of Owner's dog/puppy(s) attending Barnes-n-Bubbles K9 Spa .

- **PERSONAL PROPERTY**: Owner understands that Owner is solely responsible for any harm, including to any other pet(s), to the employees or invitees of Barnes-n-Bubbles K9 Spa, or to the equipment, facilities, or other property of Barnes-n-Bubbles K9 Spa, caused by Owners dog/puppy(s). Owner also agrees that Barnes-n-Bubbles K9 Spa shall not be responsible or liable for any lost or damaged personal property belonging either to Owner or Owner's pet.
- **FEEDING & MEDICATION INSTRUCTIONS**: Owner agrees that it is the Owner's responsibility to leave adequate supply of food and medications for Owner's dog/puppy(s) during the entire time Owner's dog is cared for by Barnes-n-Bubbles K9 Spa . Should the food/medication supply need replacement, Owner authorizes Barnes-n-Bubbles K9 Spa to purchase replacement and Owner will reimburse Barnes-n-Bubbles K9 Spa for the added cost of the actual food and medication +\$25 trip fee. Owner will leave clear precise directions on both feeding and/or medication instructions.
- **VETERINARIAN LIABILITY AND CARE**: Owner agrees to Barnes-n-Bubbles K9 Spa to obtain medical treatment for Owner's dog/puppy(s) if he/she appears ill, injured, or exhibits any other behavior that would reasonably suggest that dog/puppy(s) may need medical treatment including anesthesia. Owner agrees to be fully responsible for the cost of any such medical treatment and for the cost of any transportation for the purposes of such treatment. Owner gives permission to Barnes-n-Bubbles K9 Spa to use the nearest vet or nearest Vet hospital/24-Hour for emergency care.

- **WEAKENED IMMUNE SYSTEM**: Please note special needs dogs, young puppies, and senior dogs naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. As such, by using Barnes-n-Bubbles K9 Spa for boarding and/or Grooming the owner is waiving any claim for injury or illness experienced by Owner's dog while in our care.
- **ELDERLY DOGS**: Owners of elderly & aging dogs (approaching the end of life) need to know if in the event Owner's dog passes away while in our care, our policy is to transport Owner's dog to Owner's vet (within 30 miles) where he/she will be held until Owner can be reached by the Vet for further instructions. If Owner's vet is closed or outside of our transport distance, then we will transport to the nearest 24-hour facility.
- **PAYMENTS** are due and payable at the end of each visit. Payment may be made in Cash, ApplePay, PayPal, Zelle, VISA, Discover, or Mastercard. .
- **RIGHT OF REFUSAL**: Barnes-n-Bubbles K9 Spa reserves the right to refuse admittance to any dog or dismiss any dog that does not meet or maintain the health, temperament or other boarding & grooming standards. The determination shall be made at the sole discretion of Barnes-n-Bubbles K9 Spa staff..
- **AGREE & UNDERSTANDING**: Owner further understands and is in agreement of all provisions contained in this agreement shall be in force and effect and shall apply to each and every occasion on which Owner's dog/puppy(s) stays with Barnes-n-Bubbles K9 Spa boarding and grooming, or other services, as the case may be. This Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded by a writing signed by the parties.
